

**ACCEPTANCE OF TERMS OF TRADING**  
**To 1pm (UK) Ltd, 27 Gay Street, Bath BA1 2PD.**

- i) In this Agreement 1pm (UK) Ltd is referred to as 'you', 'your', 'the company' and the undersigned Introducer referred to as 'I', 'we', 'us'
- ii) If we comprise two or more persons we understand that our responsibilities and liabilities under this Agreement will be joint and several.
- iii) I /we agree to inform you at the earliest possible opportunity of any and all information in our possession which might in any way compromise an Agreement between your company and the Hirer and might lead to a potential loss for your company.
- iv) By entering into this Agreement I/we understand that I/we have not been appointed as your agent and accordingly I/we do not have any authority to commit you to any terms or to enter into any specific proposal
- v) I/we understand that I/we must not make any representation, commitment or promise on your behalf or purport to do so
- vi) I / we agree to refund upon demand any commission I / we have received for a transaction introduced to your company by us when the transaction is 'unwound' (ie: when your company and the Hirer and the Supplier of equipment all agree not to proceed with the transaction for whatever reason)
- vii) I / we agree to refund upon demand commission I / we have received for a transaction introduced to your company by us when the transaction is repudiated by the Hirer and terminated by your company before the first 6 months' rentals have been received, (excluding advance rental), on the following basis: before the first 3 months' rentals have been received by you, (excluding advance rental), 100% of commission shall be repaid by us – before the fourth, fifth or sixth rentals have been received by you 50% of commission shall be repaid by us. After the first 6 months' rentals have been received by your company no debit back of commission shall apply
- viii) I / we agree not to pass a proposal to your company which had been introduced to me/us originally by another leasing or finance broker unless specifically authorised by a Director of your company in writing
- ix) I / we agree to comply with all requirements of the Consumer Credit Act 1974 and agree to provide you with copies of relevant licences on request
- x) I / we agree to comply with the obligations imposed by the Data Protection Act 1998 and that all necessary approval to conduct a credit search will have been gained from each prospective Hirer by me / us; I/we further confirm that I/we will inform the prospective Hirer of the purposes for which the data I/we supply to you shall be used
- xi) I / we understand that you will respect the sanctity of the Broker / Hirer relationship and should a Hirer contact you direct for further business and if the Hirer had been introduced originally by me / us, the enquiry will be referred back to me / us and no attempt will be made by you to encourage or solicit repeat business from the Hirer while we enjoy an ongoing relationship with your company
- xii) I / we understand that, 1pm (UK) Ltd will pass title to \_\_\_\_\_ for £50.00+vat upon receipt of all Minimum term rentals from the Hirer.
